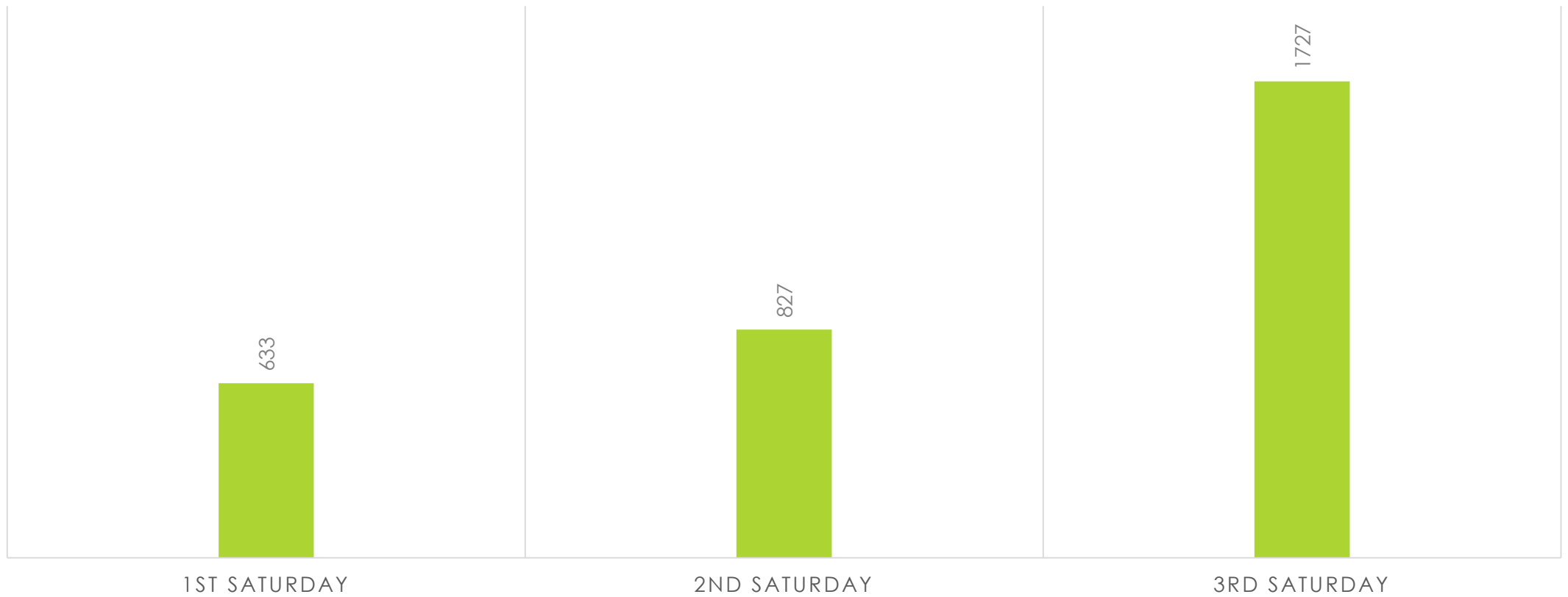

# Legal Requirements

## **24.2-411 & 24.2-701.1**

- Open Regular hours of Office of General Registrar.
- Open Starting 45 Days before Election.
- 8 hours for 2 Saturdays.
- Close 5pm Saturday Before Election.
- Additional hours can be established by General Registrar or Electoral Board.

# Anticipated Costs

\$27,000 staffing

\$5,000 set up and coordination

\$32,000 Total

- ▶ Locations are full extensions of General Registrar's Office.
- ▶ Need 5-7 Employees and 1 Manager.
- ▶ Office needs 3 staff to Support Sites.
- ▶ Adding a second week cost ~\$90,000 total due to overtime from being open for 27 days straight.

# Split Precinct Waiver & Precinct Changes

We have asked the County Board and Attorney to allow the General Registrar to request a waiver to operate a split precinct in November until redistricting can occur.

We are requesting this waiver to avoid having to move voters to a new precinct prior to November.
