## Arlington County Electoral Board Meeting Minutes June 19, 2024, June 21, 2024, June 22, 2024

The Electoral Board of Arlington County met on June 19, 2024, at the Arlington County Office Building, 2100 Clarendon Blvd., Room 318. The meeting was called to order by Chair Richard Samp at 12:00 pm. Also present were Dominick Schirripa, Vice Chair, Kimberly Phillip, Secretary and Gretchen Reinemeyer, Director of Elections.

Ms. Phillip made a motion to move into closed session pursuant to Va. Code § 2.2-3711 and Va. Code § 24.2-653 to process provisional ballots. Mr. Samp seconded. The motion was unanimously adopted. The board went into closed session at 12:01 pm.

The board came out of closed session at 12:30 pm. Mr. Samp made a motion to move out of closed session and certify that only public business matters lawfully exempt from open meeting requirements by Virginia Law, and only such public business matters as were identified in the motion convening the closed session were heard, discussed, or considered. Mr. Schirripa seconded. The motion passed unanimously.

There was a brief discussion about livestreaming the Democratic Primary Rank Choice Voting preliminary run at 5:00 pm Friday, June 21, 2024. Mr. Schirripa spoke again about the feasibility of live streaming the November 2024 Canvass.

There being no further business Mr. Samp moved that the meeting be recessed until 12:00 pm, June 21, 2024. Mr. Schirripa seconded. The motion was unanimously adopted. The Board recessed at 1:04 pm.

The board reconvened at 12:00 pm June 21, 2024, at the Arlington County Office Building, 2100 Clarendon Blvd., Room 318. The meeting was called to order by Chair Richard Samp at 12:00 pm. Also present were Dominick Schirripa, Vice Chair, Kimberly Phillip, Secretary and Gretchen Reinemeyer, Director of Elections.

Statement of Results were read and verified for fifty-four (54) precincts.

Ms. Phillip made a motion to move into closed session pursuant to Va. Code § 2.2-3711 and Va. Code § 24.2-653 to process provisional ballots. Mr. Schirripa seconded. The motion was unanimously adopted. The board went into closed session at 1:47 pm.

The board came out of closed session at 2:55 pm. Mr. Schirripa made a motion to move out of closed session and certify that only public business matters lawfully exempt from open meeting requirements by Virginia Law, and only such public business matters as were identified in the

motion convening the closed session were heard, discussed, or considered. Mr. Samp seconded. The motion passed unanimously.

The Democratic Primary Rank Choice Voting preliminary run was moved to 4:00 pm Friday, June 21, 2024, room 318. Final notice was sent as soon as both the time and room was confirmed. The preliminary run of Rank Choice Voting was conducted. It was stated for members of the public attending that these are preliminary results only.

There being no further business Mr. Samp moved that the meeting be recessed until 12:00 pm, June 22, 2024. Mr. Schirripa seconded. The motion was unanimously adopted. The Board recessed at 4:55 pm.

The Electoral Board of Arlington County reconvened on June 22, 2024, at the Arlington County Office Building, 2100 Clarendon Blvd., Room 317. The meeting was called to order by Chair Richard Samp at 11:59 am. Also present were Dominick Schirripa, Vice Chair, Kimberly Phillip, Secretary, Gretchen Reinemeyer, Director of Elections and Alyssa Myers, Deputy Director of Elections.

Mr. Schirripa made a motion to move into closed session pursuant to Va. Code § 2.2-3711 and Va. Code § 24.2-653 to process provisional ballots. Mr. Samp seconded. The motion was unanimously adopted. The board went into closed session at 12:01 pm.

The board came out of closed session at 1:21 pm. Mr. Schirripa made a motion to move out of closed session and certify that only public business matters lawfully exempt from open meeting requirements by Virginia Law, and only such public business matters as were identified in the motion convening the closed session were heard, discussed, or considered. Mr. Samp seconded. The motion passed unanimously.

A spreadsheet of envelopes that were accepted or rejected for both the Dermocratic Primary and the Republican Primary are attached as an addendum to these minutes.

Statement of Results were read and verified for early voting and same day registrations.

The Democratic Primary Rank Choice Voting final run was conducted at 2:00 pm, June 22, 2024, room 318. Final notice was sent as soon as both the time and room was confirmed. The final run of Rank Choice Voting was run. It was stated for members of the public attending that this is the final run and results will be certified during the next Electoral Board meeting, June 24, 6:00 pm, room 318.

There being no further business Ms. Phillip moved that the meeting be adjourned. Mr. Schirripa seconded. The motion was unanimously adopted. The Board adjourned at 2:16 pm.
