



Arlington County Electoral Board Meeting Minutes November 4, 2025-November 12, 2025

The Electoral Board of Arlington County met in person November 4, 2025. The meeting was called to order by Chair Dominick Schirripa at 7:29 pm. Also present was Kimberly Phillip Secretary.

Mr. Schirripa made a motion to convene the canvass. Ms. Phillip seconded. The motion carried and the canvass opened at 7:29 pm.

November 5, 2025

The Board reconvened at 12:00 pm. Mr. Schirripa called the meeting out of recess at 12:02 pm. Also present was Richard Samp, Vice Chair, Kimberly Philip, Secretary and Gretchen Reinemeyer, General Registrar.

Mr. Schirripa made a motion to move into closed session, pursuant to Va. Code 24.2-653.1, for the purpose of conducting the provisional ballot meeting. Ms. Reinemeyer, staff, and authorized party representatives are to be present. Mr. Samp seconded. The motion passed unanimously. The board moved into closed session at 12:03 pm.

The board came out of closed session at 12:30 pm. Mr. Schirripa made a motion to move out of closed session and certify that only public business matters lawfully exempt from open meeting requirements by Virginia Law, and only such public business matters as were identified in the motion convening the closed session were heard, discussed, or considered. Ms. Phillip seconded. Affirmed via voice vote:

November 11, 2025

The Board reconvened at 11:00 am. Mr. Schirripa called the meeting to order at 11:00 am. Also present was Ms. Phillip, Secretary, Gretchen Reinemeyer, General Registrar, Alyssa Myers, Assistant Registrar and Donna Patterson, Assistant Registrar. Mr. Samp arrived at 11:52 am.

Mr. Schirripa made a motion to move into closed session, pursuant to Va. Code 24.2-653.1, for the purpose of conducting the provisional ballot meeting. Ms. Reinemeyer, staff needed to assist the Electoral Board, and authorized party representatives are to be present. Mr. Samp seconded. The motion passed unanimously. The board moved into closed session at 11:01 am.
