Ms. Reinemeyer gave an update on candidates who qualified for the November general election ballot.


The Board presented the number of provisional ballots accepted and rejected. A copy is attached to these minutes for reference.


The Board signed paperwork certifying the June 17, 2025 Democratic Primary.
