

## Arlington County Election Results

The following information has been compiled from Electoral Board records and historical news sources. Much of the information from the earlier part of the period is incomplete, especially vote tallies. Data is arranged chronologically by election date and office from 1920, when Alexandria County was renamed to Arlington County, up to the present day. Vote tallies given are votes cast in Arlington County only, except if noted otherwise. The Arlington County Electoral Board and Office of Voter Registration welcomes any known additions or corrections to the listing below.

The Electoral Board has sample ballots available from 1950, when we first started using voting machines, onward. Complete election results by precinct are available from 1971 onward, with some tallies available for earlier years. The rest of the information was obtained from newspaper archives and other historical records.

When known, political party affiliation is indicated, although it did not appear on the ballot until 2001, and then only for federal and state offices.
